A Wider Circle

MCC Code/EIN: 52-2345144

A Wider Circle has been working to make sure that the recovery from this pandemic will be a recovery for all. From the beginning of this crisis, we have been responding to the unprecedented need by delivering 10,000 hot meals in partnership with World Central Kitchen, providing 2,000 care packages to our most vulnerable, assisting families in financial crises with emergency funds, helping job seekers find employment, and furnishing 2,700 homes. Our "no wrong door" approach to service ensures that regardless of a person's needs, we will work with them to find resources to support their goals, including connecting with our 500 partner agencies, with whom we collaborate regularly.

Accokeek Foundation

MCC Code/EIN: 52-6037288

The Accokeek Foundation has remained open throughout the pandemic, providing our region's residents and visitors with a safe outdoor space for recreation, relaxation, and restoration. Over the past year, we've welcomed nearly 70,000 individuals to Piscataway Park, a National Park Service site.

ACLU Foundation of Maryland

This year, the ACLU of Maryland is monitoring developments related to COVID-19 and vaccination efforts to ensure the government's response is scientifically justified and no more intrusive upon civil liberties than absolutely necessary. In particular, we continue to provide guidance to our elected officials on crafting a response that protects the populations most vulnerable to harm, including immigrants and those caught in the legal justice system. In addition, the ACLU of Maryland has partnered with students, parents, and community leaders to examine how COVID-19 remote learning and the return to in-person schooling impacts students and families. We continue to help find ways to support children and provide the tools necessary for them to succeed academically during the remote learning period and call on decision-makers to ensure that districts already struggling from decades of underfunding and that are furthest from funding equity and adequacy are given the highest priority.

Advancing Real Change, Inc.

MCC Code/EIN: 35-2518417

ARC, Inc. supports COVID-19 relief through our Client Assistance Fund which allows us to meet the basic needs for current and former clients. The pandemic underscored the overcrowding and unsanitary environments common in many correctional and detention facilities. These factors increased clients' risk of infection. Several products which health officials have recommended to help minimize exposure to coronavirus were either considered contraband or accessible only by purchase. In addition, visiting restrictions meant that the only immediate options for communication were phone and email, which are expensive. For those reentering the community and learning to manage life after incarceration, economic loss has been especially devastating during the pandemic, as one of our former clients recently expressed. During the pandemic, we have used the Client Assistance Fund to directly address the challenges many encountered as an incarcerated or formerly incarcerated person during the pandemic.

Adventist Community Services of Greater Washington

Adventist Community Services of Greater Washington provides food, diapers and clothing to needy residents in our community. During the COVID-19 pandemic the number of residents coming to ACSGW for food increased four-fold. In 2020 partnering with local CAFB, ACSGW distributed 1,058,940 pounds of food supplies, enough for 882,450 meals worth \$2,011,986. In 2020 partnering with the Greater DC Diaper Bank, ACSGW distributed 339,451 diapers to the needy children in the Community. We expanded our capacity by adding more refrigeration units to provide fresh vegetables and other food supplies. We see more and more new faces everyday seeking essential food supplies from ACSGW.

AIDS Action Baltimore, Inc.

MCC Code/EIN: 52-1512614

In 2020 and continuing in 2021 we have used the MCC funds pledged to AIDS Action Baltimore in support of COVID-19 relief by providing our services virtually through weekly Zoom support groups, in quarterly education meetings, and more individual weekly support services by phone. These included support groups and individual services for African American MSM and transgender women, promoting health and well-being, mental health and other services referrals such as HIV testing, linkage to care, medication access and adherence, food, and temporary shelter. We have also expanded our COVID-19 services into 2021 by having two grocery store gift card raffles at each support group an education meeting, mailing care packages to our clients containing gloves, masks and condoms, and creating an emergency fund for food, home essentials and utilities for people with HIV affected by COVID-19.

AIDS Research Foundation (amfAR)

amfAR is an international leader in infectious disease research. Our scientists and grantees began pivoting their HIV/AIDS infectious disease research efforts to address the COVID-19 epidemic back in December of 2019 and even earlier. To date, amfAR has awarded two rounds of COVID-19 research grants supporting the development of vaccines and improved treatments and looking at the intersection of HIV and COVID-19 infections. In fact, the science behind the Pfizer and Moderna COVID-19 vaccines has its roots in research conducted by amfAR scientists as far back as 2007. HIV research is also behind the development of the monoclonal antibody treatments being used to treat COVID patients today. In addition, amfAR conducted influential public policy studies conclusively demonstrating the disproportionate impact of COVID-19 on Black and Latinx people on a county-by-county basis across the U.S. We continue to study racial and economic disparities in the roll-out of COVID-19 vaccines.

Air Force Aid Society

The Air Force Aid Society provides emergency and education assistance to Airmen, Guardians, and their families impacted by the COVID-19 pandemic with no-interest loans and/or grants to help stabilize their situation. In 2020, Air Force Aid Society provided \$2 million in COVID assistance to Airmen, Guardians, and their families. Of that \$1.9M was for Virtual Schooling Grants to help military families with dependents in grades K through 12.

Alice Ferguson Foundation

MCC Code/EIN: 52-0694646

The Alice Ferguson Foundation has provided hands-on outdoor education experiences to children for nearly seven decades. With the onset of the COVID-19 pandemic, students, teachers and families alike were challenged with the new concept of "virtual learning" from home, creating a pressing need for programs that engaged students beyond a PowerPoint. We took the science concepts we taught to kids during hands-on adventures in nature, and found ways to recreate them through a computer screen. Using our phone cameras, we took virtual groups of kids to the barnyard, down the winding nature trails, and to the shoreline of the Potomac River. Our two live studios created a space for students to show their understanding through meaningful discussion and interactive activities with classmates from a distance. All programs are standard-aligned to the Next Generation Science Standards. More than 6,400 students, teachers and families engaged in our virtual programs this school year.

Alzheimer's Association

The Alzheimer's Association provides 24/7 support, resources and tips about the COVID-19 pandemic for people living with dementia, caregivers and families. The Association provides guidance on how to promote your loved one's safety, whether at home or in a residential care setting, plus what to do if a care setting has an incidence of COVID-19. As communities and care services begin reopening, it is important for caregivers to consider the risks and take additional safety precautions for people living with dementia.

American Cancer Society, Inc.

One of the biggest threats to overall health has been a dramatic drop in cancer screening tests due to the COVID-19 pandemic -- with up to a 90% decline in screening-related procedures in 2020, disrupting more than 22 million screening tests. The American Cancer Society, with partners, is leading a comprehensive and multi-sector, national movement to dramatically and swiftly change screening rates through local and regional stakeholder engagement and action. We are convening national influencers to identify strategies to best minimize the effects of the pandemic on cancer screening and care, and we're taking action with a public campaign to drive routine cancer screening and care.

American Friends of the School of St. Jude

MCC Code/EIN: 47-3077055

The teachers and staff at St Jude's put together 2,000 COVID-19 Family Packs for the school's 1,800 students and their families while the school was shut down because of the pandemic. The packs contained staple foods: rice, maize and beans. They also contained soap, bleach, sanitizer and instructions on how to make a mask at home. Individual home study packs and exercise books were included, too.

American Heart Association, The

MCC Code/EIN: 13-5613797

The COVID-19 Rapid Response Grants awarded 21 applicants. The focus is on innovative, highly impactful short-term proposals (9-12 months) that can show progress within the period of the award. Awards included Johns Hopkins Medicine that can address short and long term effects of COVID-19.

American Indian College Fund

We distributed over \$2.42 Million in emergency support to Tribal Colleges and Universities for COVID relief to provide everything Native American students need to stay in school and keep on track to complete their educations.

American Jewish World Service (AJWS)

Working with 519 grantees to support COVID-19 response efforts in 18 countries across Africa, Asia, Central America and the Caribbean. Support includes supplies, food, hand-washing stations and emergency cash transfers.

American Lung Association

The American Lung Association launched a \$25M initiative to end COVID-19 and defend against future respiratory virus pandemics. American Lung Association allocated funds to provide free lung health education and masks to those in need. Education includes raising awareness of lifesaving COVID and flu vaccinations. Advocacy efforts will focus on addressing racial health disparities and ensuring all Americans have access to quality and affordable healthcare.

American Red Cross, National Capital & Greater Chesapeake Region

Communities across the country count on the Red Cross for help every day — and supporting those in need is at the heart of what we do. COVID-19 has not changed our mission, we are still providing the same types of support after disasters as we always have. In 2020, the American Red Cross focused on collecting convalescent plasma to aid severely-ill COVID patients in recovery. This involved testing every unit of blood collect for COVID-19 antibodies to identify potential convalescent plasma donors.

American Thyroid Association

We have heard many concerns from patients, families, and their providers about how the novel coronavirus (COVID-19) pandemic might impact people living with thyroid conditions and have created a dedicated webpage with reliable and frequently updated information. Americares

Delivered over 14 million units of protective equipment thus far across 30 countries, including 320 tons of supplies to health care facilities in all 50 U.S. states; training at-risk facilities in infection prevention control and mental health and psychosocial services; referring patients for testing while continuing to provide clinical care. They are calling attention to the unbalanced vaccine rollout and actively preparing to deliver this critical medical care.

Amref Health Africa

Working closely with African Ministries of Health, Africa CDC and the World Health Organization to strengthen frontline health care workers and engage preventative measures. This includes leveraging technologies to improve surveillance, early detection measures, and tracking the spread of the disease. They are calling attention to the unbalanced vaccine rollout and actively preparing to deliver this critical medical care.

Assessing needs and repositioning hospitals with necessary supplies including masks, gloves and medicine, while shifting education programs to virtual settings in Lebanon and sharing information on hygiene and social distancing with vulnerable communities.

Animal Legal Defense Fund

MCC Code/EIN: 94-2681680

- ALDF set up an online tip portal where industrial animal agriculture workers could report concerns about animal abuse, worker safety, or illegal disposal.
- ALDF has been working to end high speed slaughter, a method that prevents workers from maintaining safe physical distance and increases animal suffering.
- ALDF has developed a series of papers, each outlining policy strategies calibrated to reduce specific zoonotic risks, such as conditions suspected of leading to the COVID-19 pandemic.

Animal Rescue, Inc.

People and pets that Animal Rescue, Inc.'s no-kill shelter aids are struggling in emergency situations. Some have lost their jobs, as well as their homes. Sadly, many times people remain homeless – and even live on the street or in their vehicles – rather than seek help and risk losing their pets. COVID worsened what was already a problem for people undergoing financial hardships and increased our requests for assistance. Without access to veterinary care and pet food, these pet owners have nowhere else to turn and euthanasia of a beloved pet would be their only option. To prevent tragedies like these, our no-kill shelter provides a variety of emergency services to pet owners in need to help them cope in one of the most difficult times of their lives. Campaign funds are being used to aid people and pets in crisis – and helping to keep pets and families together!

Anne Arundel County CASA, Inc.

Anne Arundel County CASA, Inc. is in the business of advocating and caring for the most vulnerable among us – children who are in foster care because they have experienced abuse or neglect. In support of that core value, we will do everything possible to support the health and well-being of those most vulnerable in our community to the spread of COVID-19 and to protect the health of our valued CASA volunteers, donors, supporters, and partners.

Anne Arundel County Literacy Council

Funds will be used to buy books and materials for low-income adults in Anne Arundel County who seek our tutoring services.

Arc Baltimore, Inc., The

When the pandemic began many of our services had to go remote, however our residential program supporting over 200 people went 24/7. Most homes had previously not required staffing during the day, however, this became necessary when day centers closed and some who worked were not able to. This extended coverage of the homes continues. Personal outreach to all those receiving remote services has continued throughout, and in early 2021, The Arc Baltimore held nine vaccine clinics in partnership with CVS and provided nearly 800 people with vaccines – both for the people we support in our programs and our staff. Because many people with developmental disabilities have physical conditions that make them more vulnerable to the virus, we are maintaining a cautious approach and continuing most safety measures. The Maryland Charity Campaign donations directly support The Arc Baltimore Family Fund which is used to provide direct assistance for people with developmental disabilities and their families. We cover things like eviction prevention, specialized therapy treatments, dental care, eyeglasses, wheelchair ramps and other crisis assistance.

Arc Central Chesapeake Region, The

Instead of closing its doors, The Arc transitioned to providing virtual services throughout the pandemic to ensure safe participation. In addition to strict PPE procedures, The Arc also implemented innovative support groups to help people with the emotional struggle of isolation.

Arc Southern Maryland, The

We support people with disabilities in their homes, at work and in the community, all who have been dramatically impacted during COVID-19.

Art with a Heart

MCC Code/EIN: 52-2227996

Art with a Heart is focusing on enriching students' virtual learning during the pandemic by ensuring there remains a truly hands-on, interactive element to their visual arts education. To this end, the organization has sourced, packed, and delivered over 11,000 art kits full of art supplies and quality digital curriculum to Baltimore City youth and other program participants. Additionally, Art with a Heart has ensured that senior citizens in the city have multiple outlets for meaningful interaction and community during a time of isolation through its community service and programming branches.

Ashland Community Development Corporation (ACDC Baltimore)

In conjunction with the Mack Lewis Boxing Gym and the We Are Us organization, we have been able to provide food relief to 732 Baltimore families. ACDC Baltimore also provided 50 families with Thanksgiving Baskets with plans to increase that number in 2021.

Ashoka

Ashoka Fellows are responding in over 200 unique and entrepreneurial ways to the crisis, from improving frontline health response technology to advancing therapeutic treatments that could be used to address inflammation caused by COVID-19 to developing low-cost respirators that can be produced on a large scale.

ASPCA: The American Society for the Prevention of Cruelty to Animals

During 2020, our team worked hard to ensure that vulnerable animals continue to receive food, shelter, and love. Thanks to supporters, the ASPCA provided urgent support to animals, pet owners, and animal welfare groups across the country through our COVID-19 emergency response, which has included:

- Establishing a \$4 million national emergency grant fund for shelters that have been severely impacted by this crisis.
- Creating regional pet food distribution centers in New York City, Miami, Asheville, and Los Angeles to give pet owners access to critical food supplies.

Assateague Coastal Trust, Inc

We pivoted from in-person community outreach and environmental education campaigns to digital platforms and increased social media saturation. We changed our Annual Native Plant Sale from an in-person retail event to a 'touchless, drive-up' event to keep staff and customers safe. Coast Kids weekend activities became online digital games to explore our rivers and bays, and this fall we shipped 'Coast Kits' to members so the entire family can get outdoors and enjoy educational activities. We developed and submitting COVID protocols to the State in order to keep the Coastkeeper's boat on the water despite statewide COVID-19 restrictions to recreational boaters. ACT's safe swimming public service website and smart phone app 'Swim Guide' was used by over 20,000 people during the 2020 swim season so they could see water quality data weekly and know if their favorite beaches, swimming holes and water recreation creeks met safe swimming EPA bacteria limits.

Association on American Indian Affairs

MCC Code/EIN: 13-1623902

As an org committed to Cultural Sovereignty, our programs, conferences and trainings went online with tremendous results. Our online community grew and thrived, allowing us to connect throughout Indian Country better than ever. We further developed a video podcast to share success stories in Indian Country. We continued to provide scholarships to students that were attending school online, and provided funding to summer camps that developed alternative methods to support Native youth over the summer.

Association for the Public Defender of Maryland

MCC Code/EIN: 45-4788005

APDM has provided information and resources for public defender clients who were released during the COVID-19 pandemic. APDM sponsored an AmeriCorps VISTA volunteer in the Office of the Public Defender's (OPD) Baltimore City office, who provided clients with information about current COVID health guidelines and the state and local emergency orders in effect at the time of their release. Through coordination with OPD staff and local grassroots partners, APDM helps connect clients with housing, treatment, and other resources to facilitate their release and to ensure that they have the support and assistance needed in the community during the pandemic.

AsylumWorks

MCC Code/EIN: 81-3205931

AsylumWorks supported asylum seekers and their families who were disproportionately affected by COVID-19. Our direct-service staff members provided clients, largely ineligible for state/federal relief packages, with emergency cash assistance, up-to-date resource guides, referrals, virtual community building activities, and emotional support. Our Job Readiness Training Program was also adapted to a virtual format to support asylum seekers whom had lost their jobs during the COVID-19 pandemic and were struggling to navigate the economic recession.

Autism Society of Baltimore-Chesapeake, The

ASBC switched from monthly in-person support group meetings to weekly virtual support groups held via Zoom. We also hosted several trainings virtually. We used MCC funds to cover the continuing cost of hosting the meetings and trainings, and to pay speaker stipends for the trainings.

Ayuda

MCC Code/EIN: 52-0971440

When the pandemic began, Ayuda was able to transition our legal and social services to be offered remotely. Our language access team has also been able to carry out their work by providing remote-interpretation and document translations. When the pandemic hit in March, and the DMV area began to shut down, we saw within that first week the immediate need from our clients for emergency assistance. More than 30 of our clients lost their jobs within those first two weeks, and we immediately launched a COVID-19 emergency relief fund. We are grateful to our individual donors, as well as foundations for their support. With that funding we've been able to sustain and expand some vital services, such as access to food and emergency financial assistance.

B&O Railroad Museum, Inc.

The B&O Railroad Museum is a community anchor in Southwest Baltimore, and, as such, felt a responsibility to reopen as soon as restrictions were lifted. The Museum was the first to safely reopen on June 25, 2020 and has successfully remained open since. Additionally, the Museum began offering online programming – both free programming for the public like virtual story times and a virtual exhibit and virtual tour options for classrooms and other organizations – and a weekly community farmers market with affordable, healthy produce, meats, and dairy products, all of which can be difficult to find in the Southwest Baltimore community.

Bailey's Cafe

We are continuing to fully fund our scholarship recipients despite the pandemic.

Ballet Theatre of Maryland

BTM safely kept new dance performances and cultural activities available to Marylanders through a variety of means throughout the pandemic, inspiring all with hope for a better future.

Baltimore Community ToolBank

We provide essential equipment for COVID-19 testing sites as well as multiple vaccination sites. Many of our partners have distributed food during the pandemic, both hot meals and bulk produce and meat. Our tools and equipment, such as tables, chairs, pallet jacks, carts, safety cones and signs, are been loaned to them at no cost so they can concentrate on their mission to feed neighbors in need and save invaluable funds for their work.

Baltimore Curriculum Project

When the COVID pandemic hit, Baltimore Curriculum Project established response workgroups. Each workgroup consisted of staff from each of the five schools. Three workgroups were created: SEL (social emotional learning), Technology, and Academics. Each group held a similar goal of preparing schools and teachers to support student learning during these unprecedented times. The SEL work group has dialed in on how BCP could address the social and emotional needs of the schools. The Academic work group developed resources for teaching reading and math online. The technology work group ensured that every BCP student received a laptop and hotspot. The workgroups continue to access the needs of students as we move through the pandemic into recovery. All BCP schools are planning intervention summer schools. Schools are hard at work creating recovery plans for the upcoming school year. Our schools are continuing to respond to family needs through food distribution efforts.

Baltimore Green Space

Many of the gardens we protect provided support to the community through food production and distribution. So the work of Baltimore Green Space allowed them to continue to serve their community in this way. We provided crucial PPE to site leaders and volunteers of the green spaces so they might be protected as they continue to care for green spaces during the pandemic. We were also able to provide support for the general upkeep and health of green sites, which were frequently visited and supported by a folks throughout the pandemic. Baltimore Green Space continues to actively support and preserve local food gardens, forests, and pocket parks created and cared for by community.

Baltimore Medical System

During the outbreak, we shifted into high gear to offer support to our 3,000 network partners. For our Network team, that meant expediting the launch of a comprehensive set of pandemic-related resources available to shelters and rescues at the Best Friends Network website. Best Friends offered grants totaling \$11,000 to partners through the Rachael Ray Save Them All Grants COVID-19 Relief Program and access to telehealth services for their foster homes. In communities around the country, a strong network of foster homes and coordinating pet food donations and deliveries. We started curbside adoptions, began door-to-door delivery of foster pets and created videos to teach volunteers how to care for newborn kittens in their homes. In this spirit of collaboration and unity, we will continue to evaluate how we can best support lifesaving nationwide during these unprecedented times. All funds are being used to support a portion of the \$845,870 spent in animal care supplies.

Bethesda Cares

Big Brothers Big Sisters of the National Capital Area

Big Brothers Big Sisters of the National Capital Area (BBBSNCA) is not directly supporting COVID-19 relief. However, we transitioned to virtual programming as a commitment to provide continued one-to-one mentoring to youth who, according to the National Institute for Health Care Management, have expressed increased feelings of loneliness and difficulties reaching their support system during the pandemic. As restrictions begin to lift, we are easing mentoring matches back into in-person programming through match reintroduction events facilitated by BBBSNCA staff.

Bikes for the World

MCC Code/EIN: 27-5426399

In 2020 our focus shifted to include providing bikes to essential workers and using bikes to deliver important information and sanitizing supplies to rural communities to help fight the spread of COVID-19.

Board of Child Care

As an essential healthcare service provider, the Board of Child Care (BCC) provides behavioral health services seven (7) days a week and around the clock. MCC funds being distributed this year will help cover the costs of virtual learning, telehealth sessions, and personal protective equipment (PPE).

Bursting With Promise, Inc.

In 2020, Bursting With Promise, Inc. donated to the organization Runway for a Cure DC's effort to provide custom masks to cancer survivors and health care personnel during the COVID-19 pandemic. Their financial assistance provided funding for 3D mammograms to patients who were either uninsured or underinsured in underserved communities in Washington, DC. In addition, Bursting With Promise, Inc. partnered with the Office of the Prince George's County Executive, Council Member At-Large Calvin Hawkins, III, and "Team Hawkins" throughout the spring, summer and fall of 2020 to support community food distribution to over 1,100 families throughout Prince George's County. Bursting With Promise, Inc. provide COVID-19 kits as part contribution to the 2020 School Supply Drive.

Cade Foundation

All events were converted to virtual due to the COVID-19 pandemic. We also added events to provide increased education and support to families who were unable to seek care due to the pandemic. We also increased the number of grants we award for fertility treatment and adoption.

Calvert Hospice

Calvert Hospice and Palliative Medicine of Southern Maryland have provided care to COVID-19 patients throughout the pandemic. Staff provided care to COVID positive patients in private homes, nursing facilities, and hospital settings, as well as via telehealth platforms. As the only hospice provider in Calvert County, we have remained the sole provider of hospice and palliative services to any individual in our community who needs it, despite facing unrepresented challenges presented by the COVID-19 pandemic.

Camp Opportunity Incorporated

In 2020 Camp Opportunity offered Camp-in-a-Box, a virtual camp experience. Materials needed for participation at home were delivered in a box to each camper. Puzzles, games, conversations in large and break-out groups, crafts, singing, talent show, theme class related to self-worth and giftedness were experienced together for 3 hours each day for a week. Quarterly gatherings were also organized and supported with materials mailed for camper use. 2021 summer camp will be virtual as well with MCC support. All experiences are free of charge to our documented abused and neglected children and their families.

Cancer Care, Inc

As a response to the heightened demand during the COVID-19 pandemic, CancerCare raised over \$4 million earmarked to provide safe transportation to and from treatment which translated to approximately 10,000 rides. CancerCare also hired four additional oncology social workers, in a time when many companies were laying off employees. These are a few of the many initiatives we undertook as a response to the pandemic and how your help during this new pledge year can assist those affected by cancer.

Capital Area Immigrants' Rights Coalition

Following the closure of immigration detention centers to visitors, CAIR Coalition shifted all of our in-detention services to remote services. We created "know your rights" videos, which are played in the facilities along with information about how to contact us. To ensure that legal services continued, we set up remote telephone hotlines. Unfortunately, despite COVID-19 spreading rapidly in crowded detention centers, the United States government refused to release many people. In response, CAIR Coalition's Immigration Impact Lab filed lawsuits to seek the release of adults and children who are detained and most at risk of serious illness, death, and/or family separation. Further, CAIR Coalition's Social Services Program has been assisting clients with access to food, clothing, medical support and other types of emergency assistance such as rent/utility support. CAIR Coalition also assists immigrants to find alternatives to their family home in which to quarantine for two weeks following their release.

CARE

MCC Code/EIN: 13-1685039

Meeting the needs of 100 million people around the world, including: equipping communities and health facilities with emergency supplies (soap, disinfectants, medication and protective gear); providing clean water and safe hygiene and sanitation resources; addressing food shortages; and educating health care workers and caregivers on prevention techniques. CARE is mobilizing resources and expertise to support vaccination campaigns that are efficient and equitable.

Care Net Pregnancy Center of Southern Maryland

We provide essential items and services to mothers and families who are pregnant: pregnancy tests/STI testing, sonograms, parenting classes, baby food/formula, and baby supplies through size 4T.

CareerCatchers, Inc., The

In response to the impact of COVID-19 on our clients we added new services, which include helping clients receive cash payments through the Montgomery County Emergency Assistance Relief Program (EARP); matching community volunteers with clients to enroll them in online training and skills development classes; adding virtual workforce development classes and workshops; and working with the influx of clients to help them apply for unemployment benefits, search for jobs online, and prepare for virtual interviews and remote work environments.

CaringMatters, Inc.

In 2021, we have successfully pivoted to virtual services, especially in our bereavement programming for adults and children. We have seen increased needs during this time of unprecedented loss and social isolation due to the pandemic. While meeting this need, we have also introduced new programming for Parents of Grieving Children and adding capacity building services and resources for other professionals in our community. Distributed MCC funds have supported all of these programs directly.

Carroll Hospice

Carroll Hospice serves an extremely vulnerable, geriatric population in Carroll, Baltimore and Frederick Counties in Maryland. Early in the pandemic's evolution, we made a strategic decision to close our doors to visitors and volunteers in order to minimize the risk to our patients. While heartbreakingly necessary for the safety of our caregivers and patients, our concerns included loved ones feeling fearful and isolated, unable to provide comfort for the patient. The onus of maintaining meaningful family communication became a new part of our caregivers' role. Philanthropic support allowed us to quickly implement technology to replicate face-to-face visits. Now, family members continue to be active participants in healthcare decision-making. We facilitate thoughtful end-of-life conversations, and in many cases have recorded final messages to family members that are keepsakes for loved ones. While hugs and closeness are limited at this time, we are diligently keeping hearts connected in every way we can.

Carroll Museums, Inc.

Our organization has lent space to smaller organizations that are unable to hold in person events or meetings because they only possess a small venue. We have a house with 8,750 square feet of space, free parking and room for social distancing. Our fire department limit is 150 people. We also have space for storage of equipment and supplies.

CASA

CASA is providing the immigrant community with direct support. In 2020 we collected and distributed cash benefits and food for our members. Throughout the pandemic we have assisted local governments in contact tracing, and with the rollout of the vaccine, we have helped coordinate vaccine clinics and schedule appointments.

CASA of Baltimore County, Inc.

During COVID, we pivoted to all-virtual means in order to continue providing the consistency of a trusted adult for children in foster care. Volunteers maintained regular contact with their assigned children, as well as the professionals, family members, and others on the children's cases. They participated in virtual court hearings, maintained communication with social services to ensure service delivery and monitoring, and they communicated with schools to keep remote learning as manageable and productive as possible. In addition this year, we provided supplies as needed and when possible, including gift cards to grocery and supply stores, masks, and other items to youth and families. In all, we were able to adjust our services so that we could continue to ensure that children remained safe in their placements and had a voice in their court cases.

The separation from peers and supportive adults and abrupt change in schedules and routines has contributed to depression, suicidal thoughts and attempts, and exacerbated mental health challenges. These challenges were further magnified for youth in foster care and kinship families who were unable to visit their birth parents or whose cases were put on hold due to court shutdowns. C.A.S.E. has seen a rise in requests for financial assistance to cover the cost of therapy. In addition, several scholars borrowed CollegeBound laptops before the announcement was made by Maryland universities to loan laptops to students in need. CollegeBound advisors have checked with each individual scholar in college and continue to monitor individual situations.

Colorectal Cancer Alliance

As a direct result of the COVID-19 pandemic, colorectal cancer screenings dropped 86% and diagnoses fell by 32%, putting 18,000 people at risk for delayed or missed diagnoses and approximately 4,500 additional deaths from this preventable disease. In response, the Colorectal Cancer Alliance expanded awareness and accessibility of screenings; connected individuals to the resources, support, and aid they need; and funded innovative, life-saving research to find a cure.

Community Action Agency of Anne Arundel County

The Community Action Agency has been at the forefront of assisting Anne Arundel County residents throughout the coronavirus pandemic. Donations From The Heart Inc.

DFTH has supported foster homes as well as nursing homes and hundreds of it's applicants during COVID-19 relief by supplying, PPE supplies to ensure the safety of our applicants that we serve as well as organizations we partner with within the local community. MCC funding has been instrumental in allowing us to continue our programs to serve the needy as well as supply things such as KN95 masks, hand sanitizers, and face shields. We are grateful for the support.

Eastern Shore Hospital Center Auxiliary

72% of our residential patient population has been deemed indigent. During COVID-19, MCC funds continue to be utilized in several ways so that these individuals may participate in all activities of daily life. Our patients have received necessities such as clothing, shoes, underwear, outerwear, hygiene products and daily healthy snacks. In addition, we implemented a program of virtual art lessons that allowed patients to attend drawing classes while COVID restricted all movement between units.

Easton Day Care Center, Inc. (DBA: Critchlow Adkins Children's Centers)

Although businesses were closed at the onset of COVID, once allowed to reopen in June 2020, CACC continued to provide childcare for families in our area. In response to COVID, safety and cleaning measures were increased and programs modified in accordance to CDC guidelines. Individual items such as art boxes, school supplies, etc. were purchased for children in all of our programs, and our before- and after-school care programs became all day programs so we could assist students with their virtual learning. For families who struggle financially, we provide tuition assistance to ensure they can afford the childcare they need. Prior to and throughout COVID, CACC continues its mission of providing quality, financially accessible childcare in a nurturing, diverse, and safe environment. MCC funds received from the previous year have been applied to our tuition assistance program.

Echo Hill Outdoor School

Echo Hill Outdoor School continues to support COVID-19 relief by providing virtual, interactive outdoor education classes to public and private Maryland students. Virtual lessons led by trained EHOS staff naturalists include Chesapeake Bay Studies, Swamp Ecology, Sensory Exploration of the Environment, Seeds and Weeds, Garbology, Survival, Orienteering, Opinions, Mystery Tour, Early American Studies, Social & Emotional Development and Team Building. The Echo Hill Outdoor School virtual classroom assists teachers by bringing various natural habitats directly to students. Grade level environmental science curriculum is presented and reinforced through visual aids, observing live specimens, and engaging online activities. Students make personal connections with the subjects they are studying and textbook material is reinforced. As of spring 2021, COVID-19 restrictions are gradually being lifted, and we are happily welcoming back Maryland students for the on campus, in-person outdoor education programs mentioned above.

Edge of the Universe Players 2, The

In the interests of public health, in 2020 and so far in 2021, we're presenting online audio plays instead of live stage plays.

Eleven21, Inc. (DBA: Epoch Dream Center)

MCC Code/EIN: 46-1753777

As a free after-school and summer camp program focused on academic progress for under-resourced youth, the Epoch Dream Center is dedicating our efforts to overcoming the academic gaps caused by the COVID-19 pandemic and the resulting virtual learning. Nationally, only 60% of students from low-income families logged on to their virtual learning, compared to 90% of their more affluent peers (Curriculum Associates, 2020). Annually, our participants receive more than 11,000 hours of academic tutoring from our organization - a number we intend to increase during 2021 as we fight to overcome learning loss in our students.

End Hunger in Calvert County

Campaign funds were used to help feed hungry families through the End Hunger Food Distribution Program which feeds over 15,000 individuals annually. Additionally, funds were used to provide breakfast and lunches to over 3,000 kids through the Kids Kits Program which provides meals to kids who would ordinarily receive meals through their schools, but had no sources of meals available due to school closures as a result of COVID.

Extra-Ordinary Birthdays

Extra-Ordinary Birthdays with health and safety precautions have continued to deliver birthdays to the most vulnerable in our communities—homeless children and their families. As a vulnerable community, have been diligent to protect not only them but staff, volunteers, and all with whom we interact. We have been delivering birthday bins while following the guidelines for social distancing by dropping them off. Each birthday bin is filled with the necessary items for each family to have their own celebration—containing theme décor, snacks and cakes, juice boxes, gift books, a gift and goody bags. An additional aspect of support during this time, has been providing personalized face masks for the birthday children and supporting them with age and grade appropriate educational workbooks during virtual learning phase. All of this support is vital to our mission as we provide hope and celebrate children while keeping them safe, well and learning.

FAME - Foundation for the Advancement of Music & Education

In 2020, FAME developed its new distance learning platform, FAME Online Learning, within one week to ensure the continuance of all programs normally provided in-person: academic tutoring, music sectionals, music theory and workshops. FAME also provided computers, internet access and instruments for students who didn't have access at home. Funding enabled us to help additional students struggling with the distance learning classes being offered by area schools. As a result students were able to maintain grade level requirement and in some cases exceeded requirements. Use of the FAME Online Learning platform is now permanent and will be used to reach and support more students.

Family Crisis Resource Center, Inc.

In 2021, FCRC provided a full range of teleservices to survivors of intimate partner and sexual violence. It was important to ensure survivors had access to services in a safe manner during the pandemic. Teleservices will continue to be available in the coming years to address health concerns and also decrease barriers to accessing services.

Family Tree, The

The Family Tree provides vital services in the prevention of child abuse and neglect during COVID-19. When the pandemic hit, The Family Tree quickly transitioned its programs to online platforms in order to meet family needs. MCC funds are being put to use across the spectrum of our programs. The 24-hour helpline and online chat provide an outlet for parents to share their frustrations and fears, they also provide up-to-date information on much-needed resources. Parenting Education and Anger Management classes, family counseling and even home visiting continue through Zoom and telehealth platforms. Parents can access The Family Tree's services without leaving their homes or interfering with their work schedules. As the pandemic persists, The Family Tree will continue services that build and strengthen families so they can provide safe and nurturing environments for Maryland children.

Feline Foundation of Greater Washington, Inc., The

The Feline Foundation (FFGW) increased its intake of cats and kittens abandoned at municipal shelters. In the early days of the pandemic, shelters were overwhelmed with surrendered cats, in part due to fears of contracting COVID from animals. As the pandemic wore on, animal surrenders increased, due to people losing their jobs and homes. FFGW pulled as many cats as possible from the shelters, to save them from euthanasia. Cats rescued by FFGW are socialized in loving foster homes, provided veterinary care, and adopted out to forever homes. FFGW does not euthanize healthy animals. Quite the contrary. Oftentimes cats rescued from emergency situations are discovered to have serious health issues, such as heart murmurs, eye infections, and structural abnormalities that require expensive procedures, surgeries and medications. Thanks to your generosity, all cats rescued by FFGW are given a solid chance at a quality of life!

Fidos for Freedom, Inc.

During the height of the pandemic, Therapy Dogs from Fidos for Freedom visited AstraZeneca to provide some comfort and stress relief to employees who were spending long hours developing a vaccine and treatments to combat effects of COVID-19. The dogs were on 6 foot leashes to maintain social distancing between humans, and everyone was masked (except the dogs) and met outdoors in a sheltered area. The employees enjoyed the respite. We continued to train service dogs and prepare clients by holding classes outside weather permitting either in our parking lot or in more isolated locations. We also conducted Zoom meetings to answer questions and guide clients in the handling of service dogs.

Firehouse Subs Public Safety Foundation

Through the Firehouse Subs Public Safety Foundation's COVID-19 Disaster Relief Fund, the Foundation has partnered with Firehouse Subs restaurants to feed more than 100,000 first responders, healthcare workers and vulnerable citizens across the country since March of 2020. The Foundation also continues to provide much-needed equipment to first responder organizations serving on the front line of the pandemic. This work will continue due to the generosity of our donors.

Fish of Laurel, Inc.

Due to COVID-19, Fish of Laurel experienced a significant increase in food distribution requests. Thanks to MCC funds, we were able to successfully respond to these requests.

In many of the countries where we serve, healthcare is not a given. In Bolivia for example, there was not the infrastructure to disseminate PPE quickly enough to keep up with the demand. Five Talents shifted our program focus from business training to ensuring that our trainers and participants were informed about safety protocols such as social distancing, washing hands and wearing masks. In some cases, funds were reallocated to purchase PPE gear and distribute this to Community Savings Groups.

Food For The Poor Inc

Food For The Poor is working to provide aid for developing nations affected by the pandemic. We frequently ship supplies (including hygiene products and PPE) to countries we serve. Additionally, we are working to address the food insecurity heightened by COVID-19.

Foundation Schools, The

The Foundation Schools serves students who come from vulnerable backgrounds that have been disproportionately affected by the pandemic and operates in the two worst hit counties in Maryland. In the last eight months alone, our staff have made over 2,700 student-home visits to deliver food, clothes, Wi-Fi, and other distance learning materials to our families. We are also fundraising to provide support in the wake of housing insecurity, job loss, medical bills, and other pandemic-related expenses. In February, we hosted a food giveaway event in partnership with Food4Thought, Inc. that served both our families and the greater community. Through our home visits and community outreach, we have attempted to mitigate some of the devastating effects of the public health crisis.

Friends of Patients at the NIH

Friends of Patients at the NIH financially supports patients who have been accepted into life-saving, ground-breaking treatment at the NIH but because financial difficulty, may need to cancel their treatment, leave early or not be able to travel to the NIH at all.

Friends of the Light House

Friends of the Light House raises money to support the Light House Homeless Prevention Center's programs: housing, employment services, and support services. Due to the COVID-19 crisis they served over 40% more clients than in a typical year. We raised over \$225,000 in direct support (and additional monies through our events programs) this year to support their programs including replenishment of their food pantry; support for their Safe Harbour Resource Center (clothing, food, sleeping bags, toiletries, etc.); and raised monies for eviction avoidance and transitional housing. The MCC funds pledged last year were part of our distribution of monies to support the Light House Programs. Note that we rely on volunteers and only one part-time employee so 90% of the monies raised go to fund these programs for the needy.

Fund for Educational Excellence

In response to the COVID-19 crisis, the Fund for Educational Excellence has helped raise and manage over \$3.9M in contributions through the City Schools' Emergency School Closure Family Support Fund and the COVID-19 Food Stability Fund to purchase technology for Baltimore City Public Schools students and to address food insecurity of Baltimore City children, families and senior citizens. The Fund will continue to fundraise for these causes, as the need unfortunately remains.

Gary Sinise Foundation

With the continued spread of the coronavirus across the nation, the Gary Sinise Foundation launched a dedicated campaign called, Emergency COVID-19 Combat Service, which addresses the needs and priorities of those impacted by the global pandemic. During this health crisis, the Emergency COVID-19 Combat Service Campaign has provided grants to first responders in need of personal protective equipment (PPE) when answering COVID-19 service calls. Financial assistance is also available to healthcare professionals, service members, veterans, first responders, and their families who have been impacted by the coronavirus. In 2020 alone, the Foundation aided military families across the U.S. by providing rental assistance, grocery gift cards, bulk food purchases, mortgage payments, and Coronavirus (COVID-19) assistance.

We have continued offering all of our programming virtually and have added new program elements (i.e., virtual bedtime stories, a virtual career week, and expanded emergency funding) during the COVID-19 pandemic. In 2021, Generation Hope will accept its largest class of Scholars in the organization's history -- helping more teen parents earn college degrees and secure jobs with family-sustaining wages, while at the same time helping the children of those teen parents prepare for success and wellbeing in kindergarten.

GOTR teaches girls the strong connection between physical and emotional health. The stress and trauma of a global pandemic has only exacerbated the need for young girls to be given the tools to adapt and summit challenging and ever-changing circumstances. There has never been a more critical time to equip young girls with confidence and strength to form compassionate connections with others and achieve their goals together. When schools closed, we adapted our researched-based curriculum to provide space for supportive conversations and activities both virtually and within small, socially-distanced groups outdoors. We have implemented new safety protocols and will continue to adapt to meet the needs of the girls we serve and their families. As the immediate threat of COVID-19 recedes, GOTR is a powerful experience, filling in the gaps of social and emotional health in girls with joy and positivity.

Girls on the Run of the Greater Chesapeake

The pandemic increased inequities in our communities, and therefore, more of our girls required financial assistance to be able to participate in the positive, youth development program. We are increasing our scholarship rate to increase access for all girls and help them connect at a critical time to nurture their social/emotional health.

In addition, we have been approved for a Maryland Humanities grant to install 15 sets of audio production gear in libraries across the state of Maryland, so patrons may record oral histories of how COVID has impacted their lives. These files will be housed by Digital Maryland, Maryland State Archives, and featured on NPR. We are also attempting to raise funds directly in support of Frederick County student musicians to conduct a virtual audio production project where they can safely network, perform and be seen and heard in a documentary-style music video via Internet-based technologies.

GO2 Foundation for Lung Cancer

GO2 Foundation has kept the lung cancer community informed and safe through a robust rapid response featuring: weekly, topical FAQs coordinated with other lung cancer advocacy organizations, specialized coronavirus webpages (updated daily) featuring links to diverse resources; and weekly live, interactive online discussions on lung cancer and COVID-19 topics through our Rapid Response Living Room.

Grassroots Crisis Intervention Center

Grassroots provides 24 hour crisis intervention services, substance use disorder screening and stabilization, and emergency shelter to families and individuals in need. Grassroots provides counseling to callers experiencing depression, anxiety, or stress due to financial hardship and are providing assistance to households behind on their rent. We provide shelter to people experiencing homelessness.

Greater DC Diaper Bank

GDCDB has seen an unprecedented need for our diapers and other essential products due to the economic impact of COVID-19 and responded by bringing 25 Diaper Need Hubs online since March 2020. Our output grew exponentially to meet the rise in demand—GDCDB put 6.2 million diapers into the hands of 25,075 families who desperately needed them. This extraordinary effort is nearly three times the number of diapers we provided in 2019 and the need has not diminished. In June alone, we distributed a record 900,000 diapers to community partners and hubs, putting distribution on pace to exceed 2020.

Greenwell designed our Nominate-a-Hero program where community members could underwrite the cost of a COVID-19 Hero to come to Greenwell for therapeutic activities and fun! Greenwell is partnering with area High Schools to offer therapeutic Re-connecting Field Trips for students identified as at-risk for mental health challenges post-pandemic. We brought our mini horse and ponies to Charlotte Hall Veterans Home in November, 2020 and visited with over 100 vets and staff.

Grow Annapolis, Inc **MCC Code/EIN: 27-2826913**

Once a month we donate food to a food pantry. If there is no produce to donate from our gardens we purchase fresh produce from a local farmers' market.

H.O.P.E. (Help for Oncology Problems and Emotional Support) **MCC Code/EIN: 23-2765683**

H.O.P.E. assists cancer patients with weakened immune systems with groceries and prepared meals. Educational assistance is provided to the children of cancer patients. H.O.P.E. also provides transportation assistance for medical appointments.

Donated 215,000 masks, respirators and face shields and nearly 25,000 protective gowns to healthcare providers.

We instituted curbside assistance for veterinary emergencies, required masks and distancing, and stopped the operation of our pet hotel and our adoption wing. We will use the MCC funds in 2021 to help support our mission funds: Mocha's Fund (veterinary care for rescued animals), Neil's Fund (extraordinary veterinary care for pets owned by low-income residents), Lola's Senior Dog Fund (veterinary care for senior dogs adopted by low-income residents), and HARThelp, our low-cost spay/neuter program.

Sharing essential prevention and control education across Africa and Asia through their community health worker network. Installing hand-washing stations and equipping communities with prevention supplies like soap and sanitizers, and continuing vital supplementation programs where possible.

The foundation of PFL is door-to-door outreach and face-to-face relationship building has been modified so we can stay connected to the most vulnerable pet owners and deliver food and supplies and urgent veterinary care our top priorities.

Humanity & Inclusion

MCC Code/EIN: 55-0914744

Adapting 37 existing programs around the world to spread prevention awareness, particularly to people with disabilities, women and children, and isolated and older people. Distribution of essential supplies has also begun.

Identity

Identity has sustained an unprecedented response to the pandemic not only by keeping young people engaged in their education, older youth developing their work skills and parents equipped to help them – but also by delivering lifesaving safety-net support and non-clinical emotional support to vulnerable families. Identity will have served 10-12,000 clients and their families this year and we expect safety net needs to continue at this very high rate next year as well. Your support through the Maryland Charity Campaign last year is part of what fueled this enormous growth and work to stave off hunger, homelessness and despair. COVID-19 devastated our client community and continues to affect them disproportionately as parents/caregivers were out of work for months, became ill or both, and many students, who were already challenged, struggled to succeed with remote schooling. Identity is now serving nine times the number of youth and families with case management as the pandemic has morphed from a short-term emergency to a more prolonged crisis.

Imagination Library of Montgomery County, Maryland

We continued, without interruption, to mail free, new, age-appropriate books directly to children's homes. For many families, these books were the only new books they received during the pandemic.

India Development and Relief Fund, Inc (IDRF)

MCC Code/EIN: 52-1555563

During the tragic COVID conditions in India in 2021, IDRF is providing relief to needy people irrespective of their religion, caste, and creed in 14 states of India. IDRF is providing groceries, oxygen concentrators, ventilators, essential medical supplies, managing vaccination drive, and transporting people living in far-flung areas to the vaccination centers. In addition to spreading awareness and providing immediate medical help for patients, IDRF is supporting a 100-bed recovery center for discharged patients and dignified cremation for those who lost their battle with the virus. To meet the current demands and prepare for future waves of coronavirus, IDRF is providing oxygen plants to small/medium hospitals. In 2020, IDRF sent \$127,000 to 8 states of India to provide 6,500 Relief-kits to poor migrant workers, medicines, PPEs, and food to medical personnel and patients. IDRF sent \$10,000 to Nepal to provide equipment and emergency supplies for COVID control and containment. In the USA, IDRF organized 36 Grab & Go food distribution events in the Washington DC metro area and provided \$267,000 worth of and groceries (around in kind worth \$200,000) to help those in distress.

Inheritance of Hope

Young families facing the loss of a parent to terminal illness could not wait to be served, so we did not wait. We created several completely online offerings for these immune-compromised families to receive hope in the comfort of their home.

The impact of the COVID-19 pandemic and its related shut downs was significant. As a result, IPC shifted its programming to a virtual format, had learning labs on how to keep your green team active during COVID and provided accompanying resources. These resources included online platforms that could facilitate green team work and regular meetings, as well as suggested creation care activities that can be done remotely and socially distanced. Increased efforts were made to connect green teams to feel a sense of community during these challenging times. We have also been helping congregations be informed about COVID relief grants that they can apply for to receive support to offset the impacts of the pandemic.

International Medical Corps

Supporting local response capabilities and integrate their response to ensure coordinated and complementary activities, while prioritizing training and capacity building of frontline health workers, deploying medicine and supplies, establishing screening and triage stations, and community outreach and engagement.

Focused on food security, healthcare, financial assistance, and domestic violence case management during the pandemic. Working across 44 U.S. states and over 145 cities with hundreds of partners to provide goods and services through IRUSA staff and volunteers.

Many of our blind clients live alone - we provide food, medicine and transportation when public transit is shut down.

It Takes A Village to Help Our Children, Inc.

It Truly Does Take a Village! – Our organization continued our COVID-19 relief support for the more than 200 ‘at risk’ students and their families that we serve. We collaborated with local agencies to conduct wellness checks, connect our families with community resources, and deliver masks to senior citizens, minority churches, and low income families. We implemented a laptop loaner program, established a virtual ‘study hall’, and provided virtual tutoring for students struggling in core subjects. We also, provided virtual essay writing and SAT Prep workshops. At our parents request, we provided fun and learning activity packets for our younger students, held daily zoom sessions with them, and delivered a 6 week virtual summer program through zoom. We collaborated with schools to use our site as a food distribution point, and in partnership with the Maryland Food Bank we delivered breakfast and lunch to our students during the summer every day.

Itineris Inc.

MCC Code/EIN: 26-1441638

Due to COVID-19, Itineris closed our onsite facility to keep our clients and staff safe. Without access to our physical location to provide supports to our clients, we had to furlough 80% of our staff. Autistic people regress in their learning 80% faster than neurotypicals, which is why it was critical to develop an online curriculum to help our clients maintain their skill level. Itineris gradually built up our virtual services for our clients. During the first two weeks of closure, we altered our class curriculums to be taught online, brought back a first wave of staff members to create and facilitate our new course schedule, contacted families to offer classes and support virtually, and gradually started enrolling clients in our virtual programs. We now have 105 of our 107 clients utilizing virtual support and/or classes and 50 staff members facilitating multiple classes, with up to 50 sessions happening daily.

Junior Achievement of Central Maryland (JA)

JA became a resource to many schools as we transitioned classroom materials to a virtual format. We were able to offer classroom programs in an online environment that infused volunteers, provided online training and support for educators, and provided student activity pages in fillable PDF formats. Our programs continued to be aligned with academic standards and provided relevant, interactive learning experiences. JA also provided access to more than 500 learning resources that could be used whether a student/classroom was engaged in a JA program in the past. We also delivered hundreds of at-home playground design kits and installed hand-washing stations and COVID-19 signage at 16 Baltimore city school playgrounds.

Kennedy Krieger Institute

Recognizing the significant need for ongoing care for pediatric survivors of COVID-19, Kennedy Krieger Institute launched the Pediatric Post COVID-19 Rehabilitation Clinic for young people who have recovered from the virus but need help to regain lost neurological and physical function due to the illness. Additionally, we hosted three free vaccine clinics for the disability community and our Center for Child and Family Traumatic Stress is a critical resource that continues to be available to all.

Kidney Cancer Association, The

Early in the pandemic, the KCA determined that the main concern among kidney cancer patients was potential disruptions to their treatments, particularly in-hospital treatments or treatments and tests as part of clinical trials. The KCA swiftly developed a kidney cancer/COVID-19 resource page that included drug production and clinical trial status updates from pharma companies. In addition, the KCA surveyed patients and worked with kidney cancer experts to develop an information page of answers to common questions about kidney cancer and COVID-19.

La Clinica del Pueblo

Our efforts centered on responding in any way possible to reduce the hardships encountered. 56% of our essential services were delivered virtually, reflecting our adoption of new technologies to ensure continuity of care. Our dedicated front-line staff provided medical care, care coordination, COVID testing, food distribution, HIV testing, and other services. La Clinica's medical interpreters ensured our patients did not "fall through the cracks" in an overwhelmed hospital system, while mental health and substance use counselors provided IT support for patients desperate to connect. In community health, staff developed new ways to reach our community through social media, virtual platforms, and many, many phone calls. MCC funds allowed us to stay afloat and provide these vital services that often provided the lifeline to our patients and the wider Latinx communities.

Lab Rescue LRCP

Lab Rescue, LRCP, works hard to meet the needs of Labs whose owners have been impacted by the coronavirus and must surrender them, as well as the increasing needs of dogs picked up as strays or pulled from abusive situations. These dogs receive comprehensive vet care, and we work to place them in foster homes as quickly as possible. Lab Rescue continues to monitor and adjust to the COVID-19 situation as it evolves in order to serve needy Labs and their owners.

Latin American Youth Center

Starting in March 2020 at the beginning of the COVID-19 pandemic, LAYC quickly pivoted to meet the new and evolving needs of our community virtually and safely, while providing emergency aid in the form of expanded and adapted social services. LAYC never closed our doors; instead, we continued our mission of providing social services to low-income youth and families while increasing capacity for direct relief services. During the pandemic, relief efforts have focused on food delivery, rental assistance, basic care access, case management, and technological support. Food insecurity remains a high need, and LAYC is setting up a more permanent internal solution to the issue in the form of a food pantry that can be accessed on an as-needed basis.

MCC funds help LARS meet the increased need for rental/utility assistance and food due to the ongoing economic impact of the pandemic. We also partnered with local restaurants to provide extra food to community members during the pandemic. In 2021 we are continuing to distribute as much rental assistance as possible to prevent eviction and homelessness.

Laurel Cats, Inc.

One of the many services that Laurel Cats offers is a cat food bank. We greatly increased the number of recipients who were receiving free cat food during the pandemic. MLA's provision of free legal services helps vulnerable Marylanders secure healthcare, avoid eviction/foreclosure, protect victims of abuse, and much more. Donations to MLA help vulnerable Marylanders protect their basic human rights and secure their basic human needs, allowing them to obtain justice, gain stability and move forward at this especially challenging time.

Liberty's Promise

We switched to online, remote programming, and strengthened partnerships with local high schools to make sure students could navigate online instruction during school closures. We also provided individual assistance to ensure that youth stayed connected to, and engaged in, their schoolwork. In virtual programming, we covered topics such as managing stress, problem solving, knowing where to ask for help, and developing or adjusting study habits. Our programs also continued to promote civic engagement, career exploration, and career readiness. We are planning to return to in-person programming in September, which will feature regular after-school meetings and field trips to local civic sites or universities. Last year, our pledges were used to distribute food gift cards to youth or to pay for a specific need. This year, we plan to use our funding to support food and transportation for our youth.

Little Sisters of the Poor, Maryland

The Little Sisters of the Poor and the Residents of St. Martin's Home remained on-site leaving the home only for medical emergencies. Testing was done on a regular basis as outlined by the Department of Health, the CDC, the CMS, and the Governor's office.

- 661 potentially violent conflicts were mediated across our two Safe Streets sites
- 77,000 grab-and-go meals were distributed to community members
- 15,000 Health & Wellness Boxes containing masks, hygiene supplies, and public health information were distributed
- 12,000 STEAM Activity Boxes were distributed to students to help mitigate learning loss

The board members and committee also increased the amount of the scholarship to help defer the expenses many of the families have incurred in educating their child during this pandemic.

Luminus Network for New Americans

Throughout COVID, today and into the future, Luminus is there, providing education and outreach related to COVID; keeping people in their homes by distributing eviction prevention funds; and providing food to our hungry neighbors. All of this occurs while staff continue their daily work of providing legal, social, and language services to the immigrant community. During COVID, many of the most vulnerable were at risk of losing their homes. By distributing eviction prevention assistance funding, we enabled 100+ families (approximately 400 people) to remain in their homes. In terms of health equity in 2020, we focused on outreach and education, attending events and providing flyers/posts in multiple languages including Spanish and Korean. In 2021, we are providing extensive outreach to promote vaccination clinics. Luminus also distributes food to our neighbors who may be experiencing a loss or reduction in income due to COVID.

Lymphoma Foundation of America

The Problem -- Cancer patients in Maryland were in a panic. They were afraid to go to a hospital or cancer center this past year for fear of COVID. At the same time, they lost wages, health insurance, couldn't pay bills, and were worried about their family members. They turned to Lymphoma Foundation of America for help. What We Did: Our registered nurse-counselors made doctor referrals to cancer centers in Maryland which had COVID protections in place. Lymphoma Foundation of America set up an Emergency Travel Fund to help patients and families travel to Baltimore and Montgomery County for lymphoma diagnosis and treatment. To help with lost wages and health insurance, we worked with a partner charity, Cancer Legal Resource Center, to advise people of their legal rights. For children with lymphoma and leukemia, we helped their parents get financial aid. Main Street Housing

Since the start of the pandemic, our goal has been to mitigate the suffering of our families disproportionately affected by this crisis. We've provided more rent relief than ever before, covering 100% of rent and utilities for families that lost their sources of income; we're providing increased food support through weekly deliveries of produce and canned goods; we modified our after-school program to a COVID safe zoom format and expanded our programming to include more academic support and a new music program. Funding we have received has primarily gone towards rent relief for our families and our bulk food orders which is ultimately distributed to upwards of 100 families per week.

As air travel virtually ceased nationwide, an infant in a Florida hospital awaited critical brain surgery. Meanwhile, in Baltimore, a top neurosurgeon was desperate to get to her and back the next day for another critical surgery. Dr. Belzberg, Director of Peripheral Nerve Surgery at The Johns Hopkins Hospital, was determined to help both patients despite the constraints – and Mercy Medical Angels came to the rescue. MMA spent found a willing pilot with an airplane large enough for social distancing. The flight got Dr. Belzberg home the same day, able to get a good night sleep and back in the operating room at Hopkins the next morning and there is a 10-month-old in St. Petersburg recovering from surgery, now with repaired nerves and a functioning arm as a result. This is just one example of how MMA has nimbly navigated COVID-19 challenges in 2020. It has also offered to transport plasma and organs and doctors. As restrictions ease, pilots are once again providing life-changing transportation to patients, adhering to new COVID-19 safety guidelines and preparing for an expected exponential increase in requests.

Mission Aviation Fellowship

MAF continues to be part of the pandemic response in remote communities around the world. MAF has flown medical staff, COVID-19 test kits, soap and PPE, medical evacuations, and now COVID-19 vaccines into isolated villages.

Montgomery Hospice, Inc.

Montgomery Hospice, Inc., has been able to provide services safely and without interruption during the pandemic, including caring for some patients with COVID-19. Even now, hundreds of individuals in Montgomery and Prince George's counties are coping with terminal illnesses and require specialized care. By utilizing personal protective equipment (PPE) and other infection control methods, our patients receive comprehensive and compassionate care, while they and their families are protected from infection. Partly due to the pandemic, our professional grief counselors are caring for more patients' families and community members than normal. Many individuals need more support since their grief is complicated by isolation resulting from sheltering at home without access to traditional rituals of mourning. When clients call PBC, staff conduct a confidential interview to assess concerns and reasons for seeking therapy. Each caller is unique and services are personalized to meet clients' needs. When matching clients with clinicians we take into consideration preferences for a counselor's cultural background/expertise, gender, and therapy style, among other factors. COVID-19 efforts included creation of a WARMLine to provide access to telephone based mental health support and supporting the Baltimore Neighbors Network, a community led initiative that paired Baltimore residents with older adults for supportive telephone calls.

Project HOPE

While our school in Uganda has been closed since March 18, 2020, the lockdown hasn't stopped RI from making an impact. We quickly pivoted our standard program offerings to COVID-19 relief support. We've supported over 250 families with bean seeds and 59 families with seedlings to provide a sustainable means to feed their families. Our teachers have conducted over 1,100 homeschooling visits to keep our students on track academically. And we effectively modified our Girl's Empowerment Program by delivering workbooks to each girl's home and supplied all 203 participants with the materials needed to start a small business.

S.A.F.E. - Supplying Allergy Friendly and Emergency - Food Pantry

Without S.A.F.E. food, clients must often choose between going hungry or eating something that will aggravate their medical conditions. We're

- seeking additional partnerships with other nonprofits to increase food distribution in the community, and
- working with Howard County's Local Health Improvement Coalition and the Community Organizations Active in Disaster to contribute to countywide efforts to serve the community at large.

Shepherd's Clinic

Shepherd's Clinic, thanks to the help of donors and volunteers, was able to increase our capacity for telehealth appointments and remote chronic disease monitoring. Shepherd's Clinic is now administering COVID 19 vaccines. So far, we have held one vaccination clinic, with another planned in June 2021. The Clinic also provided food, medical equipment and transportation to patients in direct response to COVID-19.

Shepherd's Staff, Inc., The

The Shepherd's Staff never closed down throughout 2020. Our programs, such as Easter Baskets, Call for Coats, Back-To-School took place. We continued to help with non-food essentials, which is our Blessings Closet, and offer financial assistance for those needing help. Funds that we hope to receive will be used towards the Back-To-School program. Each child who registers with us will receive a new backpack, school supplies, socks, underwear and new shoes. We have served in the past over 1100 students.

Shepherd's Table

Shepherd's Table has remained open every single day throughout the COVID-19 pandemic. We have been on the frontlines providing daily hot, nutritious meals to hundreds of people experiencing homelessness, food insecurity or poverty. We have also remained open to provide access to other critical services such as providing blankets, clothing and toiletries, and helping to pay for prescription medical costs. In 2021 we are expanding our programs to help serve the thousands of individuals that are now experiencing under employment or unemployment as a result of the pandemic. Our Beyond the Table mobile meal service is now serving every single day of the week, and in September we will begin our new Weekend Day Program which will provide a safe and productive space for our clients to spend their time and receive social services such as art therapy and job skills training.

SHORE UP! Inc.

During the pandemic, SHORE UP! offered emergency supplies to a number of families, including food and pampers for Head Start and Early Head Start families. The agency also provided CARES funding for rental assistance to individuals and families affected by COVID. Currently, SHORE UP! is a recipient of the Emergency Rental Assistance Program and is offering emergency rental and utility assistance for individuals and families who meet the necessary criteria.

Sisters Circle

Sisters Circle continues to keep our circle connected and provide safe and meaningful ways to engage. "On-your-own" mentor-mentee activities such as Glassblowing at McFadden Art Glass Studio, pasta-making classes with Schola Cooking School, Painting with a Twist take-home portrait kits, and tickets to the Reginald F. Lewis Museum, were a favorite. We offered online programs of interest, such as preparing for the high school choice process, "Y'all Hiring" workforce development training, and beginner yoga instruction. Mentor trainings explored the role of race within our mentoring relationships, the impact of adverse childhood experiences, compassion fatigue, and more. During our new virtual after-school program, we welcomed new sixth grade girls into the program. We have increased our outreach to include Thanksgiving gift bags, books from Amazon, three rounds of grocery gift cards for families, celebratory baskets for graduates, fitness trackers, holiday gift packages, and laptops for school.

Sixth Branch, The

The Sixth Branch (T6B) provides fresh produce at no cost to residents from our two community farms in East Baltimore. In 2020, we distributed more than 2,750 pounds of fresh produce and are excited to do even more this year. T6B's greenspace management program also enhances 20+ acres of community green spaces for Baltimoreans to enjoy in neighborhoods with limited park land.

In March, we activated a phased-in operating plan that included expanding behavioral health services, instituting safety protocols for staff and clients, transitioning to telehealth, and modifying our domestic violence program. Many people suffered from depression and anxiety during the crisis. Throughout the pandemic, we never had a break in service. In the face of greater demand for behavioral health and case management because of social isolation, job loss, or eviction, we stepped up and meet the need. At the same time, we continued to respond to people affected by trauma or domestic violence while still keeping everyone safe.

St. Ignatius Loyola Academy

St. Ignatius Loyola Academy provided 100% virtual learning from March 2020 through March 2021 due to the COVID-19 pandemic. To support our students and their families during this difficult time, we loaned out Chromebooks for virtual learning, helped ensure our students had adequate internet access at home, and provided grocery and other assistance to struggling families.

Story Tapestries, Inc.

COVID-19 put many artists out of work. We bought tech equipment and trained and supported artists in our network to effectively transition their incredible work to virtual platforms, successfully engaging 40 sites including public schools, early childhood centers and community centers with arts-in-education and performance experiences in 2020-21. As we launched online programming work, we became aware of thousands of families who could not afford even basic writing implements for at-home learning. We designed and delivered over 5,000 arts and activity kits that include pencils, pens, markers, clay, and other supplies as well as journals with guided activities and space for personal exploration. Activities align with each age group, from early childhood through age 60+. The Share Your Life Stories program, delivered in partnership with the Maryland Department of Aging and Area Agencies on Aging, brought kits and free storytelling performances and workshops to Maryland residents 60+, combating isolation.

Sunflower Bakery

Sunflower Bakery collected donations from our customers and we distributed over 7500 muffins in the spring of 2020 to area food pantries and shelters and to hospital staff in the metro DC area. We continued this effort in FY21, providing our customers with the opportunity to select and pay for food items that we then delivered to food pantries to assist with pandemic relief efforts.

There Goes My Hero

This fund has been in great demand as more patients were not only unemployed because of long term treatment but their financially supporting family members were also unemployed because of COVID layoffs. Other expenses increased for patients due to COVID, such as specialized transportation and specialized housing that had to be COVID clean due to a compromised immune system because of treatment. We also support meals and activities at The Hackeman-Patz house which is a long term, low cost housing option for cancer patients during treatment and medically tailored meals post discharge for patients and their families.

Thread

Thread worked with Baltimore Corps, Wes and Dawn Moore, and local community and religious organizations to create Food With a Focus (FWAF). Through FWAF, Thread purchases bulk food from local suppliers and coordinates food delivery to families from 18 distribution sites. This approach has made it possible to buy more food with fewer dollars – with the average box of 1-2 weeks of shelf-stable groceries costing \$30.47 – while preserving jobs at these companies. 100% of dollars donated to FWAF has gone to the purchase of food, and more than a year after the pandemic began, Thread has served more than 18,000 families through this initiative. 57 Thread Families continue to receive regular groceries through FWAF.

TowerCares Foundation

Even before the COVID-19 pandemic, military families faced a range of challenges related to employment, education, job training, childcare, and food insecurity. The COVID-19 pandemic exacerbated and complicated these issues. Specifically, (1) Military and veteran families reported increased stress and incidence of mental health symptoms—23% of military family respondents without a pre-existing depressive disorder or anxiety diagnosis now report having symptoms. (2) Military spouse unemployment worsened—17% of military spouses reported having lost their job. (3) Too many military families experienced food insecurity—7% of veteran families sought emergency food assistance. By addressing the financial needs of military families through our programs such as Unmet Needs (assistance for rent, mortgage, utilities, vehicle repair, food and basic assistance), we have lessened the financial and emotional burdens caused by COVID-19.

Volunteers of America Chesapeake, Inc. (DBA: Volunteers of America Chesapeake & Carolinas)

Throughout the pandemic VOACC has supported our clients and the surrounding communities. This spring, in partnership with Walgreens, our VOA Hope Center, a certified community behavioral health center (Prince George's County), distributed the Pfizer vaccine to 300 Marylanders. Distribution continued throughout the year. Early on staff and clients received ongoing education on how to prevent the spread of the coronavirus, as well as the needed cleaning/sanitizing supplies and personal protective equipment. When in-person services were closed, telemedicine was implemented for all our behavioral health services allowing enrolled clients to continue receiving critical services. Early release of ex-offenders to home confinement during the pandemic, increased our Residential Re-entry Center clients by 42%, averaging 175 clients in home confinement and 60 in-house. Emergency services were distributed to housing clients, ensuring basic needs continued to be met, transportation was accessible, and central Wi-Fi to support virtual learning and access to other services. VOACC did not participate in the 2020 Maryland Charity Campaign.

Warrior Canine Connection

Public health experts anticipate a surge in demand for mental health care services due to COVID 19, but even before the pandemic only a quarter of the demand in our country was being met, and a staggering 22 Veterans take their lives each day. During this global health crisis, WCC worked diligently to move all programming to new virtual formats so that those Veterans most in need could continue to have the critically-important Warrior Canine "Connections" that research shows reduce stress and isolation. By developing videos and instructional tools, WCC has helped Veterans stay engaged and facilitated their continued rehabilitation and recovery.

Washington County Commission on Aging, Inc.

Washington County Commission on Aging, Inc. assisted over 2000 seniors and those living with disabilities to receive a COVID vaccine from the local hospital and/or local Department of Health. Washington County Commission on Aging, Inc. also assisted homebound clients (home delivered meals AKA Meals on Wheels (MOW)) without any transportation to receive a COVID vaccine. Additionally, Washington County Commission on Aging, Inc.'s staff and volunteers ensured through the home delivered meals (MOW) program that seniors, those with disabilities and the medically homebound had access to essential hygiene supplies and non-perishable food in the midst of the pandemic. This was done by way of food and supply deliveries at least every two weeks through home delivered meals (MOW). To mitigate the spread of COVID the Washington County Commission on Aging, Inc. called every client prior to every delivery to make sure they were well, if client indicated they had a COVID like symptom then deliveries were made to these individuals in full personal protective equipment. MCC funds have always and will continue to support the home delivered meals (MOW) program.

Washington County Museum of Fine Arts

We continued to work to achieve our mission of serving the community through the transformative power of art even while closed. Educators produced daily art lessons for teachers and families to use for online instruction. New programs and social media initiatives connected to the collection through humor and through deeper learning--social media, videos, blogs, and email were used to continue to reach people. We reopened July 21, 2020 after three months of closure and immediately resumed our exhibition schedule although continued to teach via the internet--providing summer camps and our traditional Saturday Morning Youth Program. Supplies were purchased and organized into kits for pickup at the museum. Our education department also worked closely with the public schools to help teachers with creative distance learning.

Water for People

Wildlife rehabilitators in Maryland are required to be licensed. With so few having the all the different permits our director has for many species of wildlife. WVUCI supported pandemic relief efforts in 2020 with 21 events that included working with American Legion Post 233 and other Veteran Service Organizations to feed the Community, have an academic event on the Hill, gave out over 300 Certificates, donated diapers to the Katherine Foundation, held a 9/11 Memorial Service as well as Memorial Day, and Veteran Day Services, Breast Cancer Events, Christmas Memorial Service for those who died during COVID, participated in a Parade in Boonsboro, MD, distributed face mask to Popeye's and Ashley Stewart employees, distributed Santa Hats to Pico Pico and Burger King employees, sent 4 boxes overseas to active duty military, collected clothes at Charlotte Hall and more. We plan to continue with our many, many programs this year with the funds we receive and will include a seminar for men with MST and PTSD and so much more.

Women's Center, The

Since the start of COVID-19, the Center has experienced an increase in requests for our sliding scale mental health and domestic violence services that help individuals, couples, and families who lack financial resources to meet basic needs, have fewer educational and employment opportunities, and do not have access to quality mental healthcare. These disadvantaged clients are experiencing eviction, increase in frequency and severity of abuse, financial stress, grief, and loss of employment. Left untreated, the consequences of mental illness and domestic violence on our community are staggering – unnecessary disability, unemployment, homelessness, homicide, suicide, and family distress. In 2020, the Center successfully transitioned from a 100% office based mental health and domestic violence service provider to a virtual service provider to meet the increasing demand for the Center's reduced fee mental health counseling and domestic violence services during the pandemic.

Women's Law Center of Maryland, The

It is estimated that domestic violence rose at alarming rates during the pandemic due to lockdowns, quarantines, and financial instability of families. WLC remained open during the pandemic, and our attorneys continued to help victims of domestic violence stay safe when they needed us most. We will continue to do this in 2021, and donations are vital for us to continue this work.

Women's Microfinance Initiative

WMI's programs are targeted to the most underserved populations in East Africa – poor rural women in those parts of Uganda, Kenya, and Tanzania that typically receive little to no public support. In 2020, many of our loan program members suffered severe damage to their businesses from pandemic-related government lockdowns, shuttered marketplaces, stay-at home orders restricting buyers, closed public transit systems, and looting. We provided emergency loans to women who lost inventory or had to temporarily close their businesses so they could get up and operating again. Without these loans, we are certain our borrowers and their families would spiral downward into the poverty we have worked so hard to alleviate over the past 13 years. We also assisted our 14 loan programs to operate safely by purchasing the COVID-related personal protective equipment, infrared thermometers, masks, pedal-operated hand washing stations and hand sanitizer necessary to reduce the spread of COVID.

The food distribution efforts started in March 2020 continue across our region through food pantries, Y Fresh Markets, and individual food deliveries to families that lack transportation. In March 2021, the Y opened its doors to its first permanent food distribution site, Y Druid Hill Food Pantry. In addition, the Y continues to operate 26 Academic Support Centers to support students who are participating in virtual learning.
